#### CANCELLATION

AWS must be informed in writing regarding intent to cancel no less than 30 days from the first date of the event. The official cancellation date will be the date written notification is received by AWS. Should an exhibitor cancel, all payments received by the official cancellation date will NOT BE REFUNDABLE.

#### OTHER REGULATIONS

Tabletop set-up will be 7:00am to 8:00am on the first day of the event. Tear down will be after 1pm on the last day of the event. No display items will be allowed anywhere off the table area. Table logo draping will be allowed over the front of the table. Any additional services such as electrical service will be at the expense of the exhibitor. Each Exhibit Representative Agrees to abide by These REGULATIONS. The on-site AWS staff person shall have the right to enforce these regulations and may shut down any exhibit that does not comply without refund.

#### EXHIBIT HOURS

**Day 1** will be 8am to 9am, 12pm to 1pm, 5pm to 6pm and during breaks. **Day 2** will be 8am to 9am and 12pm to 1pm.
